

AN ORDINANCE FOR THE PURPOSE OF AMENDING ORDINANCE NO. 505-2000 OF THE CITY OF AUXVASSE, MISSOURI, WHICH PROVIDES FOR WATER RATES WHICH ARE TO BE CHARGED BY THE CITY OF AUXVASSE, MISSOURI FOR CUSTOMERS WITHIN THE CORPORATE LIMITS OF THE CITY OF AUXVASSE, MISSOURI AND CUSTOMERS OUTSIDE THE CORPORATE LIMITS OF THE CITY OF AUXVASSE, MISSOURI, WHICH RATES ARE SETFORTH IN TWO NEW SECTIONS.

WHEREAS heretofore the City of Auxvasse, Missouri has in ordinance number 505-2000 enacted charges to be made to water customers of the City of Auxvasse, Missouri, and it is determined that the rates charged therein are not sufficient to adequately pay for and maintain the municipal water system of the City of Auxvasse, Missouri, and that it is therefore reasonable and necessary that the rates for the costs of water provided to the customers of the City of Auxvasse, Missouri, be increased as hereinafter setforth, NOW THEREFORE

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF AUXVASSE, MISSOURI, AS FOLLOWS:

Section 1: The rate to be charged water customers of the City of Auxvasse, Missouri, for water delivered through the municipal water system of the City of Auxvasse, Missouri, to locations within the City of Auxvasse, Missouri, as setforth in Section 1 of Ordinance No. 388 as thereafter amended by Ordinance No. 505 - 2000 of the City of Auxvasse, Missouri are herewith amended so that the charge for water so delivered by the City of Auxvasse, Missouri within the City of Auxvasse, Missouri is as follows:

The monthly charge to be made by the City of Auxvasse, Missouri, for all water delivered or made available to customers of the City of Auxvasse, Missouri, water system within the City of Auxvasse, Missouri shall be as follows:

\$8.50 for the first 1,000 gallons;

\$4.25 per 1,000 gallons for all gallons in excess 1,000 gallons.

Section 2: The rate to be charged water customers of the City of Auxvasse, Missouri, for water delivered through the municipal water system of the City of Auxvasse, Missouri, to locations beyond the corporate limits of the City of Auxvasse, Missouri, as setforth in Section 2 of Ordinance No. 388 as amended by ordinance No. 505 - 2000 of the City of Auxvasse, Missouri, are herewith amended so that the charge for water so delivered by the City of Auxvasse, Missouri beyond the corporate limits of the City of Auxvasse, Missouri, is as follows:

The monthly charge to be made by the City of Auxvasse, Missouri, for all water delivered or made available to customers of the City of Auxvasse, Missouri, water system beyond the corporate limits of the City of Auxvasse, Missouri, shall be as follows:

\$8.50 for the first 1,000 gallons;

\$4.25 per 1,000 gallons for all gallons above 1,000 gallons;

Plus a sum equal to 25% of the cost of all water at the above water charge plus an additional \$4.00 surcharge.


Section 3: This ordinance shall be in full force and effect from and after the 1st day of March, 2001.

READ THE SECOND TIME AND PASSED by the Board of Aldermen of the City of Auxvasse, Missouri, this 19th day of February, 2001.




