

WHEREAS heretofore the City of Auxvasse, Missouri has in ordinance number 517-2001 enacted charges to be made to water customers of the City of Auxvasse, Missouri, and it is determined that the rates charged therein are not sufficient to adequately pay for and maintain the municipal water system of the City of Auxvasse, Missouri, and that it is therefore reasonable and necessary that the rates for the costs of water provided to the customers of the City of Auxvasse, Missouri, be increased as hereinafter setforth.

AN ORDINANCE FOR THE PURPOSE OF AMENDING SECTION 2, ORDINANCE NUMBER 517-2001 BY DELETING THEREFROM THE PROVISIONS RELATING TO AN ADDITIONAL CHARGE OF 25% PLUS A \$4.00 SURCHARGE AS THE SAME RELATES TO THE WATER CHARGES TO BE PAID BY THE CUSTOMERS OF THE CITY OF AUXVASSE, MISSOURI WATER SYSTEM FOR WATER RECEIVED BEYOND THE CORPORATE LIMITS OF THE CITY OF AUXVASSE, MISSOURI, AND SUBSTITUTING THEREFORE AN ADDITIONAL CHARGE OF \$10.00 FOR THE FIRST 5,000 GALLONS OF WATER PER MONTH PLUS \$0.75 FOR EACH 1,000 GALLONS OF WATER IN EXCESS OF 5,000 GALLONS OF WATER PER MONTH.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF AUXVASSE, MISSOURI, AS FOLLOWS:

Section 1: Section 2, Ordinance Number 517-2001 is hereby amended by deleting therefrom the following portions thereof, to-wit:

“Plus a sum equal to 25% of the cost of all water at the above water charge plus an additional \$4.00 surcharge

And substituting therefore the following words:

“Plus an additional monthly charge of \$10.00 for the first 5,000 gallons of water delivered or made available and a further additional charge of \$0.75 per 1,000 gallons of water for each 1,000 gallons or fraction thereof in excess of 5,000 gallons of water.”

So that hereafter the monthly charges to be made to made to water customers of the City of Auxvasse, Missouri for water delivered through the municipal water system of the City of Auxvasse, Missouri, to locations beyond the corporate limits of the City of Auxvasse, Missouri shall be as follows:

The monthly charge to be made by the City of Auxvasse, Missouri, for all water delivered or made available to customers of the City of Auxvasse, Missouri, beyond the corporate limits of the City of Auxvasse, Missouri, is as follows:

\$8.50 for the first 1,000 gallons

\$4.25 per 1,000 gallons for all gallons above 1,000 gallons
PLUS an additional monthly charge of \$10.00 for the first 5,000 gallons of water delivered or made available and a further additional charge of \$0.75 per 1,000 gallons of water for each 1,000 gallons or fraction of water thereof in excess of 5,000.


Section 2: This ordinance shall be in full force and effect from and after the 15th day of May, 2002.


