

WHEREAS heretofore the City of Auxvasse, Missouri has in its ordinances enacted charges to be made to sewer customers of the City of Auxvasse, Missouri, and it is determined that the rates charged therein are not sufficient to adequately pay for and maintain the municipal sewer system of the City of Auxvasse, Missouri, and that it is therefore reasonable and necessary that the rates for the costs of sewer provided to the customers of the City of Auxvasse, Missouri, be increased as hereinafter setforth.

AN ORDINANCE FOR THE PURPOSE OF AMENDING THE ORDINANCES OF THE CITY OF AUXVASSE, MISSOURI RELATING TO SEWER CHARGES TO BE PAID BY THE USERS OF THE MUNICIPAL SEWER SYSTEM OF THE CITY OF AUXVASSE, MISSOURI AND ENACTING ONE NEW SECTION WHICH PROVIDES FOR SEWER CHARGES TO BE PAID BY THE USERS OF THE CITY OF AUXVASSE, MISSOURI SEWER SYSTEM OF THE CITY OF AUXVASSE, MISSOURI.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF AUXVASSE, MISSOURI, AS FOLLOWS:

Section 1: The charges to be paid to the City of Auxvasse, Missouri, as sewer charges for each water customer of the City of Auxvasse, Missouri, shall, after the effective date of this ordinance, be as follows:

The monthly sewer charge to be made by the City of Auxvasse, Missouri, for all water delivered or made available to customers of the City of Auxvasse, Missouri, water system within the City of Auxvasse, Missouri, as sewer charges shall be as follows:

- \$15.00 for the first 1,000 gallons
- \$4.00 per 1,000 for all gallons in excess of 1,000 gallons or fraction of 1,000 gallons
- Plus a \$4.00 surcharge

The sewer charge hereinabove provided shall be in addition to the water charge due to the City of Auxvasse, Missouri, for the delivery of water by the City of Auxvasse, Missouri to water customers within the City of Auxvasse, Missouri, which currently is established and provided for in Ordinance No. 532-2002.


Section 2: This ordinance shall be in full force and effect from and after the 31st day of May, 2003.

READ THE SECOND TIME AND PASSED by the Board of Aldermen of the City of Auxvasse, Missouri, this 15th day of May, 2003.


