

AN ORDINANCE FOR THE PURPOSE OF REPEALING ORDINANCE NUMBER 530-2002 OF THE CITY OF AUXVASSE, MISSOURI, RELATING TO CERTAIN FEES CHARGED AND DEPOSITS PAYABLE TO THE CITY OF AUXVASSE, MISSOURI, RELATING TO THE USE OF THE WATER SYSTEM, THE SEWER SYSTEM, CITY OF AUXVASSE, MISSOURI CEMETERY, MERCHANT'S LICENSES, PEDDLER'S LICENSE AND PET LICENSES AND ENACTING IN LIEU THEREOF SEVEN NEW SECTIONS RELATING TO THE SAME SUBJECT MATTER.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF AUXVASSE, MISSOURI AS FOLLOWS:

Section 1: Ordinance Number 530-2002 of the City of Auxvasse, Missouri is herewith repealed.

Section 2: Charges and Fees to be paid by the customers of the City of Auxvasse, Missouri, water system in addition to the water usage and surcharge fees, if any, otherwise imposed by the ordinances of the City of Auxvasse, Missouri, which fees and charges shall be paid prior to the usage of water from the City of Auxvasse, Missouri water system by the customer to the City of Auxvasse, Missouri, are as follows:

Water Turn On Charges	\$ 5.00
Water Turn Off Charges	\$ 5.00
Deposit to Use Water Which Deposit Shall be Paid Prior to Usage of Water From the System	
¾ inch or less water connection	\$ 150.00
Greater than a ¾ inch water connection and less than a 2 inch water connection	\$ 300.00
2 inch or greater water connection but Less than a 3 inch water connection	\$ 500.00
3 inch or greater water connection but Less than a 4 inch water connection	\$ 750.00
4 inch or greater water connection	\$ 1,500.00
Late Fee For Payment of Water Charge	25.00
Water Reconnection Fee	25.00
Water Tap Fee	250.00

Section 3: Charges and Fees to be paid by the customers of the City of Auxvasse, Missouri, sewer system in addition to the sewer usage, surcharge fees, if any, otherwise imposed by the ordinances of the City of Auxvasse, Missouri, which fees and charges shall be paid prior to connection to the City of Auxvasse, Missouri, sewer system are as follows:

Sewer Tap Fee	\$250.00

Section 4: An annual Pet License Fee shall be paid by the owner of each cat and dog residing within the City of Auxvasse, Missouri, which License fee shall be paid within 10 days after the owner of such cat and dog resides within the City of Auxvasse, Missouri, and said license fee shall be for the period from the date herein provided to the end of the then current year from the date herein provided to the end of the then current year and each year or portion of a year thereafter that said owner resides within the City of Auxvasse, Missouri, said Pet License Fee shall be paid to the City of Auxvasse, Missouri,

Pet License	\$5.00

Section 5: License Fees to be paid to the City of Auxvasse, Missouri, by Merchants and Peddlers doing business within the City of Auxvasse, Missouri, in addition to any charges or fees otherwise imposed upon said

Merchants or Peddlers by the City of Auxvasse, Missouri, which License Fee shall be paid prior to such merchant or peddler doing business within the City of Auxvasse, Missouri, are as follows:

Merchant's license (annual fee)	\$	25.00
Peddler's license (daily fee)		10.00 per day

Section 6: Fees and Charges to be paid in conjunction with the opening of a grave or other cemetery openings in the City of Auxvasse, Missouri Cemetery for the deposit of human remains are as follows:

Openings four feet or less in length including Openings to deposit bodily remains after cremation	\$150.00
Openings more than four feet in length and less than Six feet in length	\$220.00
Openings more than six feet in length	\$400.00

The moneys paid for the fees and charges for openings in the City of Auxvasse, Missouri Cemetery shall be paid as follows:

- i. \$50.00 to the City of Auxvasse, Missouri and
- ii. The remainder of such fees and charges shall be paid to the provider of the opening service who has been approved by the Board of Aldermen of the City of Auxvasse, Missouri to provide such service.

Section 7: The charges, licenses and fees setforth in Section 2 through 6 of this ordinance shall be in addition to all other charges made by the City of Auxvasse, Missouri, which are not inconsistent with the provisions hereof.


Section 8: It shall be unlawful for any person to make use of the services of the City of Auxvasse, Missouri or the City of Auxvasse, Missouri Cemetery for which a fee, license or charge is setforth hereinabove without first having paid said sum to the City of Auxvasse, Missouri or the service provider as provided for in Section 6 hereof and upon conviction thereof shall be assessed a fine of no less than \$10.00 and no more then \$500.00 or sentenced to a term of from one to thirty days in the City Jail or by both such fine and imprisonment.

Section 9: This ordinance shall be in full force and effect from and after the date of its passage and approval.

READ THE SECOND TIME AND PASSED by the Board of Aldermen of the City of Auxvasse, Missouri, this 16th day of June, 2003.




